PROGRAM PROVIDES OUTREACH AND CASE MANAGEMENT FOR HOMELESS PERSONS. THE SOAR PROJECT HELPS THE HOMELESS SIGN UP FOR SSI AND SSDI BENEFITS. HOUSING COUNSELING PROVIDES HELP TO PEOPLE FACING FORECLOSURE OR IN NEED OF PRE-PURCHASE EDUCATION. THE PROGRAM ALSO COORDINATED THE VOLUNTEER INCOME TAX PROGRAM THROUGH THE IRS FOR MAHONING COUNTY. THESE PROGRAMS ASSISTED A TOTAL OF 7,066 HOUSEHOLDS.
