ADS IS A NON-RESIDENTIAL FACILITY THAT PROVIDES BASIC NEEDS TO SENIORS ON A DAILY BASIS. DIGNITY IS GIVEN TO OUR PARTICIPANTS THROUGH MEANINGFUL ACTIVITIES AND SOCIALIZATION BASED IN SHARED EXPERIENCES. IN ADDITION TO ENRICHING THEIR DAILY LIVES, THE SERVICES PROVIDED HELP CLIENTS REMAIN IN THEIR FAMILY HOMES LONGER THAN OTHERWISE POSSIBLE.
