DIGNITY IS GIVEN TO OUR PARTICIPANTS THROUGH MEANINGFUL ACTIVITIES AND SOCIALIZATION BASED IN SHARED EXPERIENCES. IN ADDITION TO ENRICHING THEIR DAILY LIVES, THE SERVICES PROVIDED HELP CLIENTS REMAIN IN THEIR FAMILY HOMES LONGER THAN OTHERWISE POSSIBLE.

IN THIS TRADITION, THE AGENCY PROVIDES INDIVIDUALS WITH PAYMENT ASSISTANCE FOR UTILITIES AND RENT. BASIC NEEDS SERVICES SUCH AS EMERGENCY FOOD RELIEF AND FOOD PANTRY HELP THE NEEDY IN BOTH STARK AND PORTAGE COUNTIES. MEETING OTHER BASIC NEEDS, THE AGENCY DISTRIBUTES COATS, SCHOOL SUPPLIES, CHRISTMAS GIFTS, AND ASSISTS IN ATTAINING FURNITURE AND CAR REPAIRS. THE AGENCY'S ULTIMATE GOAL IS TO ADDRESS THE EMERGENT NEEDS OF PEOPLE IN OUR COMMUNITY, WHICH OFTEN MEANS CONNECTING THEM WITH APPROPRIATE PROGRAMS OUTSIDE OF THE AGENCY.
